Hire of the barns comes with these Terms and Conditions:

At the Llyn Gwynant Barns you create your own wedding in our beautiful stone buildings set in spectacular private fields above the lake. But this is not a hotel: we clean the bathrooms and run a bar on the wedding day, but you organise your own food and entertainment with a group of friends to help. Hire comes with these conditions:

- **Private functions only:** No publicly advertised parties or events are allowed.
- **You need friends** to help manage parking, move tables, clear glassware and serve toasts and table wines.
- **Alcohol:** guests must know not consume their own alcohol on site on the days that our bar is open other than pre-agreed corkage drinks. They can bring their own drinks for nights without a bar.
- **Any business on our site** needs our prior approval and to agree our T&Cs for outside contractors.
- **Caterers in our kitchen** must be approved, though you and your guests can use the kitchen if you take care.
- **Fire safety** is your responsibility, read the safety instructions displayed in Kitchen barn. Use the woodburner fireguard provided and keep firewok at least 6 m from buildings. No candles, flares, fireworks, sky lanterns, straw or hay bales.
- **Outdoor firewok, firepits and bbqs** 3m from buildings but not on the grass please, keep on hard standing.
- **Child safety:** fires, rough ground, steep drops and water are hazards nearby: please look after young children.
- **Food safety** is the responsibility of barn users or contractors; please be careful, hygienic and safe.
- **No excessive noise or disturbance** is to be audible at the public campsite after 11pm. Only acoustic music (**not** sound systems) outside, and only during the day. Large sound systems/DJs/bands cease playing at midnight, along with last orders at the bar. Sound levels are monitored, please designate a 'responsible person' to liaise with staff.
- **Security** is your own responsibility. Keys for outside doors are supplied, please return on check-out.
- **Arrive at 2pm for check-in** but we may need access until 4pm for cleaning; fields are available at midday for tent company by arrangement. **1pm check-out** on your last day with a £50 charge for each hour's delay.
- **Maximum number of guests** is 120 including children, infants are not counted.
- **Extra days hire for weekend weddings** at a low rate for up to 35 people, Big barn accessible by us for cleaning.
- **Overnight guests** stay in the barns or barn fields only – no wedding guests on the public campsite.
- **No nails, staples or other sharp objects** are to be put in any beams, ceilings or walls, anywhere.
- **No paper confetti** is permitted anywhere but petals or leaves are welcome inside and outside the barns.
- **Dogs** are not encouraged, nor allowed inside. Dogs outside must be kept on a leash at all times.
- **Our pagoda on the front terrace** is the only marquee allowed on site: we have underground services to protect.
- **Vehicle parking** is your responsibility: ask our staff for advice. Cars may park around the barns, in Barn yard and in the overflow car park. Parking is not allowed on grass, alongside the public road or on the campsite driveway.
- **Vans and caravans** may park at top of Barn field or in Barn yard, where electric hook-ups are located.
- **Our electricity supply is limited** so no extra heaters or catering equipment without prior approval.
- **Clean up:** the barns are not serviced accommodation – you must leave them and the fields in tidy condition, floor swept/mopped, with all rubbish in bins and glass, cans, paper and plastic separated for recycling.
- **Extras** including corkage must be ordered and paid 8 weeks before arrival and are not available after this time
- **A refundable bond** is due in advance and may be withheld if conditions are not met.

Payment schedule: A deposit of **£1000** is required to confirm a booking. An instalment of £2000 is due 8 months before arrival. The remaining balance plus a £750 refundable bond is due 8 weeks before arrival when extras also should be finalised and paid. Payments are made online via a payment link on your invoice, or by internet transfer to *Gwynant Ltd*, HSBC sort code: 40-37-13 a/c no: 61726471.

Our cancellation policy: If you cancel your wedding, please advise us as soon as possible. If it is more than 8 months before your arrival date, we will refund £600 of the £1000 deposit if we re-sell the date. If you cancel within 8 months of the booked date, then the £2000 instalment and the initial deposit are not refundable.

Your bond is normally refunded by internet transfer within 14 days of your departure.
